The complaining witness says that on the date and at the location described above, the defendant contrary to law

**COUNT: 1 ASSAULT WITH INTENT TO MURDER**

did make an assault upon Trooper Donald DeSnyder with intent to commit the crime of murder; contrary to MCL 750.83. [750.83].

FELONY: Life or any number of years

**COUNT: 2 POLICE OFFICER - ASSAULTING/RESISTING/OBSTRUCTING CAUSING INJURY**

did assault, batter, wound, resist, obstruct, oppose, or endanger Trooper Donald DeSnyder, a police officer of Michigan State Police that the defendant knew or had reason to know was performing his or her duties, and caused a bodily injury requiring medical attention or medical care to that person; contrary to MCL 750.81d(2). [750 81D2]

FELONY: 4 Years and/or \$5,000.00

**COUNT: 3 ASSAULT WITH A DANGEROUS WEAPON(FELONIOUS ASSAULT)**

did make an assault upon Trooper William Hewitt with a dangerous weapon, to-wit: a motor vehicle, but without intending to commit the crime of murder or to inflict great bodily harm less than the crime of murder; contrary to MCL 750.82. [750.82].

FELONY: 4 Years and/or \$2,000.00

**COUNT: 4 POLICE OFFICER - FLEEING - THIRD DEGREE - VEHICLE CODE**

being the driver of a motor vehicle to whom was given a visual or audible signal by hand, voice, emergency light, or siren by Trooper Donald DeSnyder, a police officer who was in full uniform and the officer's vehicle was identified as an official police vehicle, acting in the lawful performance of his/her duty, directing the defendant to bring his/her motor vehicle to a stop, did wilfully fail to obey that direction by attempting to flee or elude the officer, and the violation resulted in a collision or an accident and in an area where the speed limit was 35 miles per hour or less; contrary to MCL 257.602a(3). [257.602A3-A]

FELONY: 5 Years and/or \$1,000.00

**COUNT: 5 MALICIOUS DESTRUCTION OF FIRE OR POLICE PROPERTY**

did, wilfully and maliciously destroy or injure certain personal property, to-wit: patrol vehicle, belonging to or possessed by Michigan State Police; contrary to MCL 750.377b. [750.377B]

FELONY: 4 Years and/or \$5,000.00

**COUNT: 6 CONTROLLED SUBSTANCE - POSSESSION OF MARIHUANA**

did knowingly or intentionally possess the controlled substance marihuana; contrary to MCL 333.7403(2)(d). [333.74032D]

MISDEMEANOR: 1 Year and/or \$2,000.00 The court shall impose license sanctions pursuant to MCL 333.7408a.

**COUNT: 7 OPERATING - LICENSE SUSPENDED, REVOKED, DENIED/ALLOWING A SUSPENDED PERSON TO OPERATE**

did operate a motor vehicle upon 7th Street, a highway, while his or her operator's license was suspended or revoked; contrary to MCL 257.904(3)(a). [257.9041B]

MISDEMEANOR: 93 Days and/or \$500.00; vehicle immobilization (see MCL 257.904d)

**HABITUAL OFFENDER - SECOND OFFENSE NOTICE**

Take notice that the defendant was previously convicted of a felony or an attempt to commit a felony in that on or about February 9, 2000, he or she was convicted of the offense of Conspiracy to Commit Assault GBH in violation of MCLA 750.84[C] in the 31st Circuit Court Court for St. Clair County, State of Michigan;

Therefore, defendant is subject to the penalties provided by MCL 769.10. [769.10]

PENALTY: One and one-half times the maximum sentence on primary offense or lesser term
